Notice is hereby given that on 27th July 2016, in accordance with Regulations 14 and 35 of the Town and Country Planning (Local Planning) (England) Regulations 2012, Ipswich Borough Council adopted the Shop Front Design Guide Supplementary Planning Document (SPD), the Cycling Strategy SPD, and Revisions to the Local List (Buildings of Townscape Interest) SPD. The report for the Council meeting on 27th July 2016 can be viewed on the Council's website (www.ipswich.gov.uk).

The Shop Front Design Guide SPD provides guidance in relation to shop fronts in both older and modern buildings, including specific guidance relating to specific elements of a shop front including materials, colours, fascias and signage. The SPD supports the implementation of adopted Core Strategy policies DM5 (Urban Design Quality), DM8 (Conservation Areas) and DM9 (Buildings of Townscape Interest).

The Cycling Strategy SPD provides detailed guidance in relation to designing routes, junctions and crossings, signage, surfacing and cycle parking and storage as part of new development. The document also identifies potential improvements for cycling throughout Ipswich. The SPD supports the implementation of adopted Core Strategy policies CS20 (Key Transport Proposals), DM15 (Travel Demand Management), DM16 (Sustainable Transport Modes), DM17 (Transport and Access in New Developments) and DM19 (Cycle Parking).

The adopted Local List SPD already identifies buildings and structures, which are of local architectural and historic interest or make a significant contribution to the character and appearance of the town, but do not meet the criteria for statutory listing. The revisions to the Local List SPD include eight additional properties that have been added to the List. The SPD supports the implementation of adopted Core Strategy policy DM9 (Buildings of Townscape Interest).

Any such application must be made no later than 3 months after the date on which the SPD was adopted.
